The Students' Estimated Cost of Attendance (COA), or the Student Budget, is established annually and early in the year for each class, and is used to determine a student's maximum financial aid eligibility for an academic year. For financial aid purposes, the Cost of Attendance (COA) is an estimate of the total cost to attend the College and includes both direct (required) and indirect costs. In accordance with regulations governing student aid programs, a student's total financial aid package, including loans, should not exceed the estimated cost of attendance. Figures are subject to change without notice.

Direct Costs- The College Tuition, The Student Fees are the direct costs billed to the student, The College Tuition includes academic learning resources. The costs are listed and are based upon full-time attendance during the academic year. Student Account https://TheCollegenm.org/students/bursars-office/. Indirect Costs- other COA components are education-related expenses. These components are included to determine student eligibility for financial aid and to help a student estimate the cost of living while enrolled at the College.

- *** Students that are located at a Clinical Hub that is out-of-area, will receive automatic housing adjustments to support changes in housing markets at specific out-of-area hub locations. Updates to a cost-of-attendance will be based on research, housing market changes and volatility, and scarcity of housing.
- ¹Housing expenses reflect the average costs of living on or off campus in the Borderplex area. Because federal regulations do not allow housing costs to be tailored to individual student, a student's personal housing arrangements does not affect the cost of attendance used by the Office of Financial Aid. For those students that are placed at a clinical hub with a volatile housing market, an adjustment to the cost-of-attendance housing component will be automatic. A student will be notified of an increase in the cost-of-attendance by April.
- ²Miscellaneous and personal expenses component is an allowance for items such as utilities, clothing, personal care products, vision/dental insurance, laundry, and other incidentals.
- 3"Transportation allowance includes the cost of travel between the student's residence and the institution, and the necessary travel to complete a course of study, including clinical rotations. An additional travel allowance for residency interviews and clinical rotation travel is included in the estimated cost-of-attendance."
- ⁴Exam fees include COMLEX® Level I, COMLEX® Level II- CE, and Level 2- PE. The USLME®, although recommended, is not a graduation requirement, and will be considered in the cost of attendance. Fees updated annually on July 1.

- ⁶The total cost-of-attendance cannot be tailored to an individual student's quality of life, but the Office of Financial aid will do professional judgements for students with extenuating circumstances and approved elective clinical rotations that need additional travel expenses.
