

2026-2027 Independent Verification Worksheet V5

Your 2026-2027 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information, we will compare your FAFSA with the information on this verification worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You must complete and sign this form, attach any required documents, and submit the form and other required documents to us. We may ask for additional information.

B. Household Size

C. Independent Student’s Income Information to Be Verified

1. TAX RETURN FILERS:

Instructions: Complete this section if the student and spouse filed or will file a 2024 IRS income tax return(s). If you used the IRS DRT tool to retrieve our income tax information prior to the IRS disabling the service, in most cases no further documentation is needed to verify 2024 income information that was transferred into the student’s FAFSA using the IRS DRT if that information was not changed by the FAFSA filer.

In most cases the IRS Tax Return Transcript will be available within 2–3 weeks after the 2024 electronic IRS income tax return has been accepted by the IRS. Generally, for filers of 2024 paper IRS income tax returns, the 2024 IRS income tax return information is available within 6–8 weeks after the 2024 paper IRS income tax return has been received by the IRS. Contact the Financial Aid Office if more information is needed about obtaining an IRS Tax Return Transcript.

If the spouse filed a separate 2024 IRS income tax returns, the IRS DRT cannot be used and the **2024 IRS Tax Return Transcript(s)** must be provided for each.

2. TAX RETURN NONFILERS—Complete this section if you, the student (and, if married, your spouse), will not file, and **are not required** to file, a 2024 income tax return with the IRS.

D. High School Completion Status

- A copy of the student's final official high school transcript that shows the date when the diploma was awarded.
- A state certificate or transcript received by a student after the student passed a State-authorized examination that the State recognizes as the equivalent of a high school diploma (GED test, HiSET, TASC, or other State authorized examination).
- An academic transcript that indicates the student successfully completed at least a two-year program that is acceptable for full credit toward a bachelor's degree.
- For a student who was homeschooled in a state where state law requires the student to obtain a secondary school completion credential for homeschooling (other than a high school diploma or its recognized equivalent), a copy of that credential.

- For a student who was homeschooled in a state where state law does not require the student school completion credential for homeschooling (other than a high school diploma or its recognized equivalent), a transcript, or the equivalent, signed by the student's parent or guardian, that lists the secondary school courses the student completed and includes a statement that the student successfully completed a secondary school education in a homeschool setting.

A student who is unable to obtain the documentation listed above must contact the financial aid office.

E. Identity and Statement of Educational Purpose

Identity and Statement of Educational Purpose (To Be Signed at the Institution)

The student must appear in person at the **Burrell College of Osteopathic Medicine** to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated by the institution with the date it was received and reviewed, and the name of the official at the institution authorized to receive and review the student's ID.

In addition, the student must sign, in the presence of the institutional official, the Statement of Educational Purpose provided below.

Identity and Statement of Educational Purpose (To Be Signed in the Presence of a Notary)

If the student is unable to appear in person at the **Burrell College of Osteopathic Medicine** to verify his or her identity, the student must provide to the institution:

- (a) A copy of the unexpired valid government-issued photo identification (ID) that is acknowledged in the notary statement below, or that is presented to a notary, such as, but not limited to, a driver's license, other state-issued ID, or passport; and

(b) The original Statement of Educational Purpose provided below, which must be notarized. If the notary statement appears on a separate page than the Statement of Educational Purpose, there must be a clear indication that the Statement of Educational Purpose was the document notarized.
